Summary of Assessment Findings

Describe overall assessment findings and faculty members' interpretation of the assessment results: The results presented here reflect the third dataset collected under the 2017 CDIS Assessment Plan. As with previous Assessment Reports, we note that the data is preliminary and additional datasets are needed to identify clear trends. However, some emerging trends deserve discussion by the CDIS faculty and staff.

- There appear to be consistent differences in how grades are assigned on the Stillwater and Tulsa campuses.
- In-class assessment of oral communication skills does not match up with other data, including an independent analysis of oral presentations, as well as first-year oral communication outcomes.

Finally, it is notable that less data was available for the 2018-2019 report compared to previous years. This problem may be specific to the transition to Canvas. However, if a similar paucity of data is available for the 2019-2020 report, this should be discussed by the CDIS faculty.

It was reviewed by committee members Ms. Donita Tefft, Dr. Roha Kaipa, and Dr. Yu Zhang. It was also reviewed by the CDIS department head, Dr. Ramesh Kaipa. Describe the process for sharing and discussing assessment findings with program faculty: Initial assessment results were shared with the entire department during a faculty retreat on Friday, August 16th. The full assessment report will be provided to the entire CDIS faculty in advance of the October 2019 faculty meeting.

Based on data collected this year, what changes are being considered or planned for the program?: As mentioned above, the Assessment Report may be used to improve feedback provided to students regarding skills related to the program outcomes. Such changes are pending approval by the CDIS faculty.

Based on this year's findings, what (if any) changes are planned for the assessment process?: Although not included in our Assessment Plan, this assessment report was supplemented by a comprehensive exam provided to most CDIS seniors. The comprehensive exam was not administered in Tulsa as planned, but we hope to implement this change for the 2019-2020 Report.

Describe the process for implementing these changes/planned program improvements: Instructors on the Tulsa will be identified who can administer a comprehensive exam and record student oral presentations. These changes are planned for the spring 2020 semester.
